



## Licence Agreement

updated 25 Oct 2019

This agreement applies to any video produced using the Just Click Videos web application available at [www.justclickvideos.com](http://www.justclickvideos.com) or downloaded, streamed or otherwise sourced from [www.justclickvideos.com](http://www.justclickvideos.com).

When you, a registered user of the Just Click Videos web application produce and/or download a video from the Just Click Videos web application (“**Video**”), you agree to be bound by the terms of this Licence Agreement, the justclickvideos.com Privacy Policy and the Terms of Use. The Privacy Policy and Terms of Use are incorporated into this Licence Agreement by reference.

The following order of precedence applies in the event of any inconsistency between this Licence Agreement, the Privacy Policy and the Terms of Use:

- (a) Licence Agreement;
- (b) Privacy Policy; and
- (c) Terms of Use.

Subject to the terms and conditions contained in this Licence Agreement, you are granted certain rights to use any Videos that you produce and/or download for non-broadcast purposes including publication on websites, social media and/or display at meetings.

1. All Video graphics used or made available as part of the Just Click Videos application are the sole and exclusive intellectual property of Real IT Unit Trust (“**Just Click Videos**”), except the Content (defined in section 7 below).
2. For each Video you produce or download from [www.justclickvideos.com](http://www.justclickvideos.com) you are granted a licence to use and publicly display or communicate the Video for commercial or personal purposes on online publications only, but only for the purpose of listing and advertising properties for sale or rent, showcasing sold or leased properties (whether commercial properties or otherwise), or any other purposes agreed in writing by us from time to time (and to authorise others to do so). This licence is granted on a non-exclusive, worldwide, non-assignable, non-transferable and revocable basis.
3. The rights granted under section 2 above are subject to the following restrictions:
  - 3.a. The audio file(s) used in a Video (“**Audio**”) may not be transferred, copied, or duplicated by itself, either in whole or in part, other than in timed-relation with the Video. Further, the Audio, may not be resold, licensed, leased or in any way distributed to any third party.
  - 3.b. Release or redistribution of the Audio (e.g., making it available for download via the internet) is not permitted.
  - 3.c. Use of the Video file (with or without Audio) in any items for resale, licence or other distribution for profit is not permitted.
  - 3.d. Including the Video file (with or without Audio) in templates of any nature, including templates for websites, documents, projects or otherwise for distribution and/or sale to third parties is not permitted.
  - 3.e. Use of the Video (with or without Audio) in design template applications intended for resale, whether online or not, including, without limitation, website templates is not permitted.
  - 3.f. Use of the Video (with or without Audio) to create a derivative work based on or incorporating the Video is not permitted.

4. This Licence Agreement does not authorise or permit any use of any Video that is not expressly set forth herein or to make any other use of a Video not expressly authorised hereunder. Just Click Videos reserves all rights not expressly granted to you hereunder. All rights granted hereunder are granted on a non-exclusive basis.
5. Just Click Videos accepts no responsibility or liability for special, indirect or consequential damages or any damages whatsoever, including any loss of business or business profits loss of income or revenue, loss of contracts, loss of anticipated savings, loss or corruption of data, loss of goodwill, wasted management or office time resulting directly or indirectly from, or otherwise arising out of or in connection with, the use of a Video, whether in an action of contract, negligence or other tortious action.
6. This Licence Agreement is binding upon, and shall inure to the benefit of, any respective successors and/or assigns of the parties hereto.
7. You warrant that you own, or are the licensee of, the images, files and other content that you upload to justclickvideos.com or include in the property listing URL on the Just Click Video web application that is embedded in the Video, including any copyright or other intellectual property rights that may subsist in that content (collectively, **Content**).
8. You warrant that you have the necessary right, title or interest to upload and use the Content and share the Content with Just Click Videos to incorporate into Videos and that its use will not infringe the rights of any third party.
9. You warrant that you have obtained all necessary consents for Just Click Videos to incorporate the Content into Videos, including any consents from the authors and creators of the Content to any acts or omissions by Just Click Videos that would otherwise infringe the moral rights of those authors and creators.
10. You indemnify Just Click Videos for all claims, losses, damages and liabilities that Just Click Videos incurs or suffers as a direct or indirect result of your breach of sections 7, 8 or 9.
11. You grant Just Click Videos a non-exclusive, non-revocable, perpetual, transferrable licence to use the Content for incorporation into the Videos and its own marketing and promotional purposes.
12. You can only use a Video for lawful purposes. Also, you can't use a Video in connection with material which is illegal, offensive, defamatory, pornographic, obscene or demeaning, or promotes discrimination.
13. You must attribute Just Click Videos in all publications of the Videos by referring to Just Click Videos. You must not remove any watermark that Just Click Videos places on the Videos.
14. IN THE EVENT OF ANY MATERIAL BREACH OF THIS AGREEMENT OR ANY USE OF THE VIDEOS BY A THIRD PARTY, ALL RIGHTS GRANTED TO YOU UNDER THIS AGREEMENT SHALL TERMINATE IMMEDIATELY. YOUR CONTINUED USE OF THE VIDEOS SHALL CONSTITUTE AN INTENTIONAL INFRINGEMENT OF THE COPYRIGHTS IN AND TO THE VIDEOS. THE COPYRIGHT OWNER(S) OF THE VIDEO HEREBY RESERVES ALL OF THEIR RIGHTS TO LEGAL AND FINANCIAL REMEDIES AND RELIEF.
